

**Junior Miss Jessamine County Fair Pageant**

**RULES**

1. Contestants must show proof of age when sending in applications. Contestants must have reached her 8<sup>th</sup> birthday and cannot have reached her 13<sup>th</sup> birthday as of October 31, 2011.
2. Contestants will be required to attend a mandatory practice on Wednesday, July 13, 2011 at 11:00 pm at the Jessamine County Fairgrounds.
3. Contestants will be judged on poise, personality, beauty, and in an on stage interview by individuals from outside Jessamine County.
4. Contestants will appear in a casual outfit consisting of jean shorts, a white shirt (not tank tops), and sandals and an age appropriate dress.
5. Suitable and valuable prizes will be awarded to the winners.
6. Only one person will be allowed in the dressing room with each contestant. This rule will be strongly enforced.
7. The winning contestant will be expected to retain her Junior Miss Jessamine County Fair title until a new queen is crowned the following year.
8. All contestants' names and ages, along with complete address and phone numbers must be turned in at the time of entry.
9. The pageant committee reserves the right to dismiss at any time a contestant who does not show a proper amount of cooperation and courtesy to committee members, consultants, and fellow contestants.

## JUDGES CRITERIA

Each of the three areas of judging is given equal weight. One-third of your score will come from the Interview, one-third from casual, and the final third from age appropriate dress. Your scores from each of these categories are compiled to select the contestants with the highest scores.

Overall, the judges are looking for the girl they believe:

- Is confident, in control and gives intelligent responses
- Has positive body language and good eye contact
- Can support opinions
- Is honest, sincere, spontaneous, and has a sense of humor
- Is well groomed and fashionable
- Is poised in interview and on stage
- Has an attractive smile, face, and hair

During the Interview, the judges are looking for poise, personality, articulation, appropriate responses, intelligence, self-assurance, confidence, charm, and natural beauty.

During the casual wear competition, the judges are looking for physical fitness, facial beauty, poise, self-assurance, projection, showmanship, eye contact, and fit and appropriateness of outfit.

During the dress competition, the judges are looking for gracefulness in gown, facial beauty, poise, eye contact, projection, self-assurance, overall presence, showmanship, and fit and appropriateness of dress.

## **WHAT YOU WILL NEED**

- Outfit for open production- Jean shorts, white shirt (no tank tops), and some type of sandal
- Casual Wear- Same outfit as opening number
- Age Appropriate Dress- Dress and shoes must be age appropriate
- Accessories- Don't overdo. Don't plan to wear something that will be taken off on stage. This is not allowed.
