2. An entry fee of \$25.00 per contestant is required. Payment can be made in the form of cash, money order, or certified check made payable to the Jessamine County Fair. **NO PERSONAL CHECKS WILL BE ACCEPTED!!!**
3. Contestants will be judged on poise, showmanship, natural beauty, and an on stage interview.
4. Contestants must have reached her 5th birthday and cannot have reached her 8th birthday by midnight June 30, 2011.
5. Contestants may wear Sunday dresses or play clothes. No formal dresses.
6. Contestants must not have competed in professional shows for money.
7. Winners will receive a crown and trophy.
8. Entry forms, entry fees, and a copy of each contestant's birth certificate (state or hospital issued) must be postmarked by Wednesday, June 29, 2011. **NO LATE ENTRIES WILL BE ACCEPTED!!!**
9. Judges' decision will be final.
10. No refund of entry fee.
11. The contestants will be disqualified from the competition and forfeit any ribbons or other winnings if information is falsified on application.
12. Once you have won in this age group at the Jessamine County Fair, you are not eligible for this age group again.
13. All contestants must attend practice on Wednesday, July 13, 2011 at 10:00 am at the Fairgrounds.
14. Contestants must be at the Fairgrounds the night of the pageant at 6:30pm.
