RULES AND REGULATIONS

The pageant is for Jessamine County residents only.

Contestants are required to be at the Jessamine County Fairgrounds one hour before the pageant begins. Registration begins at 4:00 pm and ends at 4:45 pm. If your child is not registered by 4:45, your child will not be allowed to participate.

An entry fee of \$10.00 per contestant is required. Payment can be made in the form of cash, money order, or certified check made payable to the Jessamine County Fair. **NO PERSONAL CHECKS WILL BE ACCEPTED!!! IF PERSONAL CHECKS ARE SENT, THE CHECK WILL BE RETURNED AND THE CHILD WILL BE DISQUALIFIED FROM THE EVENT!!!!**

Each contestant will receive a trophy and ribbon.

Contestants will be judged on poise, showmanship, and natural beauty. All babies are to be dressed in swimsuits/beachwear. Nor formal dresses or tuxedos.
