## **RULES AND REGULATIONS**

Pageant is open to all Jessamine County residents.

An entry fee of \$25.00 per contestant is required. Payment can be made in the form of cash, money order, or certified check made payable to the Jessamine County Fair. **NO PERSONAL CHECKS WILL BE ACCEPTED!!!!**

Contestants will be judged on poise, showmanship, natural beauty, and on an onstage interview.

Contestants must have reached her 8<sup>th</sup> birthday and cannot have reached her 11<sup>th</sup> birthday by October 31, 2010.

Contestants may wear age appropriate long or tea length dresses.

Contestants must not have competed in professional shows for money.

Winners will be crowned Miss Pre-teen Jessamine County Fair. She will be awarded the entry fee and one night room expense to represent the Jessamine County Fair at the annual Junior Miss Kentucky County Fair Pageant to be held October 2010 in Louisville, Kentucky, and sponsored by the Kentucky Association of Fairs and Horse Shows.

All contestants will receive participation ribbons.

The winner will receive a crown, sash, arm bouquet, and trophy.

Contestants who place will receive a trophy and ribbon. All contestants will receive a participation ribbon.

Entry forms, entry fees, and a copy of each contestant's birth certificate (state or hospital issued) must be postmarked by Friday, June 26, 2010. **NO LATE ENTRIES WILL BE ACCEPTED!!!!**

Judges' decision will be final.

No refund of entry fee.

The contestants will be disqualified from the competition and forfeit any ribbons or other winnings if information is falsified on application.

Once you have won in this age group at the Jessamine County Fair, you are not eligible for this age group again.

All contestants must attend practice on Tuesday, July 6, 2010 at 11:00am at the Fairgrounds.

Contestants must be at the Fairgrounds the night of the pageant at 7:00 pm.
