## **RULES AND REGULATIONS**

Pageant is open to all Jessamine County residents.

An entry fee of \$30.00 per couple is required. Payment can be made in the form of cash, money order, order certified check made payable to the Jessamine County Fair. NO PERSONAL CHECKS WILL BE ACCEPTED. IF PERSONAL CHECKS ARE SENT, THE CHECK WILL BE RETURNED AND THE CHILD WILL BE DISQUALIFIED FROM THE EVENT!!!!

Contestants will be judged as a couple on poise, showmanship, natural beauty, and an on stage interview.

Contestants must have reached his/her 5<sup>th</sup> birthday and cannot have reached his/her 8<sup>th</sup> birthday by midnight June 30, 2010.

Contestants may wear Sunday dresses or play clothes. It is suggested the boy wear a coordinating outfit.

Contestants must not have competed in professional shows for money.

Winners will represent the Jessamine County Fair during County Fair Day at the Kentucky State Fair in Louisville, Kentucky. Winners will compete as a couple at the state and entry fees for the state competition will be paid by the Jessamine County Fair. The Jessamine County Fair will also pay for two parents of each contestant for admission into the Fair and each contestant will receive \$25.00 for spending money.

Winners will receive the following: Girl-a sash, crown, a trophy and ride tickets for the night of the pageant. Boy-a medallion, a trophy and ride tickets of the night of the pageant. Runners-up will receive a trophy and ribbon. Runners-up will be expected to represent Jessamine County at the State Fair in case the winners cannot attend.

Winners will also be required to attend the Fair the rest of the week to assist in the presentation of awards and to be recognized.

All contestants will receive participation ribbons.

Entry forms, entry fees, and a copy of each contestant's birth certificate (state or hospital issued) must be postmarked by Monday, June 14, 2010. NO LATE ENTRIES WILL BE ACCEPTED!!!!

Judges' decision will be final.

No refund of entry fee.

The contestants will be disqualified from the competition and forfeit any ribbons or other winnings if information is falsified on application.

Once you have won this age group at the Jessamine County Fair, you are not eligible for this age group again.

All contestants must attend practice on Thursday, July 8th at 11:00 am at the Fairgrounds. Contestants must be at the Fairgrounds the night of the pageant at 7:00 pm.
