# *Miss Teen Jessamine County Fair*

## **RULES AND REGULATIONS**

The Miss Teen Jessamine County Fair is an OPEN pageant which means contests do not need to be a resident of Jessamine County to participate.

Contestants must be single, never married, never had a marriage annulled, and never had any children. They must not have won any other preliminary competition to the 2010 Miss Teen Kentucky County Fair Pageant. Previous queens of the Miss Teen Jessamine County Fair Pageant are not eligible to compete.

Contestants must show proof of age when sending in applications. Contestants must have reached their 13<sup>th</sup> birthday and cannot have reached their 16<sup>th</sup> birthday as of October 31, 2010.

Contestants will be required to attend a mandatory practice session and interview on Saturday, July 3<sup>rd</sup> at 12:00pm at the Jessamine County Extension Office. All contestants will wear a white shirt, khaki capris, and some type of sandal or flip flop for the interview. Practice will take place as other interviews are being conducted.

Contestants will be judged on poise, personality, beauty, and an interview by individuals from outside Jessamine County.

Contestants will appear in casual outfit consisting of khaki capris, a white shirt (no tank tops), and sandals and a floor or tea length evening dress.

Only one person will be allowed in the dressing room with each contestant. This rule will be strongly enforced.

Suitable and valuable prizes will be awarded to the winners.

The winning contestant will be expected to participate in the Miss Teen Kentucky County Fair Pageant to be held the following October.

The winning contestant will be expected to retain her Miss Teen Jessamine County Fair title until a new queen is crowned the following year.

Marriage or motherhood during her reign constitutes loss of the Queen's title. The title is then relinquished to the First Runner-up, providing she fits the criteria.

All contestants' names and ages, along with complete addresses and telephone numbers, must be turned in at the time of entry.

The pageant committee reserves the right to dismiss at any time a contestant who does not show a proper amount of cooperation and courtesy to committee members, consultants and fellow contestants.

**ENTRY DEADLINE – Must be postmarked by Monday, June 14, 2010.**
