RULES AND REGULATIONS

The pageant is for Jessamine County residents only.

Contestants are required to be at the Jessamine County Fairgrounds one hour before the pageant begins. Registration begins at 5:00 pm and ends at 5:45 pm. If your child is not registered by 5:45, your child will not be allowed to participate.

An entry fee of \$15.00 per contestant is required. Payment can be made in the form of cash, money order or certified check made payable to the Jessamine County Fair. **NO PERSONAL CHECKS WILL BE ACCEPTED!!! ANY PERSONAL CHECKS SENT WILL BE RETURNED AND THE CHILD WILL BE DISQUALIFIED FROM THE EVENT!!!!**

Each contestant will receive a trophy and ribbon.

Contestants will be judged on poise, showmanship, and natural beauty.

All babies are to be dressed in clothes which are cool and comfortable. No formal dresses or tuxedos.

Classes: Girls Ages: 1 year old, 2 years old, 3 years old and 4 years old

Boys Ages: 1 year old, 2 years old, 3 years old and 4 years old

All winners will receive a trophy and ribbon.

All judges' decisions are final.

Entry applications, entry fees and a copy of each contestant's birth certificate (state or hospital issued) must be postmarked by Wednesday, June 30, 2010. **NO LATE ENTRIES WILL BE ACCEPTED.**
